

- How to prioritize so you don't spread your initiatives too thin.
- Why you shouldn't cascade your strategy and what to do instead.
- How to measure the right things so you know you're making progress.
- How to move from analysis paralysis to rapid action and learning.
- How to coach others to take more ownership.
- How to reduce meetings across the organization.
- How to develop an organization that creates results through autonomy and alignment.




